Statoil invest US\$4 million (Tsh. 8.6 billion) Indian Company gets US\$32.98 million to train local oil and gas engineers contract from Dawasa

Oil and gas major Statoil Tanzania has spent US\$4 million to train local experts in the industry as part of its human resource development strategy in the country. The investment made since 2012 amounts to Tsh.8.6bn/- at the current mean official exchange rate of 2,151/-. Under it, Statoil, which has to date discovered 22 trillion cubic feet (tcf) of gas in the country, seeks to support and build capacity of Tanzanians to enable them participate fully in the emerging prosperous oil and gas economy. Speaking in Dar es Salaam at the graduation ceremony of nine students sponsored by the company under the capacity building initiative, the Sustainability Manager said the graduates had been undertaking a Master's Programme related to oil and gas under the Statoil Tanzania scholarship programme known as Angola Tanzania Higher Education Initiative (ANTHEI). The statement said ANTHEI was a programme that provides full scholarships of up to ten students annually to pursue MSc Petroleum Geoscience degrees in Petroleum Engineering at the Norwegian University of Science and Technology (NTNU).

Tanzania, Toshiba sign MoU to drive Dar, Beijing agree on seven priority geothermal power generation

Toshiba Corporation has signed an MoU with Tanzania Geothermal Development Company Limited (TGDC) to promote the development of geothermal power generation in Tanzania. Established in 2013, TGDC is a subsidiary of the Tanzania Electric Supply Company (Tanesco), which seeks to drive geothermal in the country. Toshiba will contribute to geothermal power generation in Tanzania, including the development and provision of major equipment, creation of plant operation guidelines for and personnel management, and training. Although about 97 per cent of Tanzania's electricity supply is currently dependent on hydro and fossil fuels, the country plans to increase the current 1,577MW of installed power generation capacity to 10,000MW by 2025, with geothermal now included.

Symbion Power plans 400MW production from Mtwara by 2019

Construction of a 600 megawatts gas to electricity plant in Mtwara is expected to start in 2017 of currently negotiations between state owned Tanesco and US based Symbion Power are successful with the first 400MW fed into the national grid by 2019. All studies for the project are due for completion by end of March 2016 when the two sides will start discussions on various contractual agreements that will clear the way for construction of the power plant. The Symbion Power Mtwara project is a 600MW combined cycle gas to electricity project that will be developed through PPP with the government through Tanzania Electric Supply Company (TANESCO).

The Vice-President (VP), Ms Samia Suluhu Hassan, held conversation with Chinese President Xi Jinping in Johannesburg during the Forum on China - Africa Cooperation and agreed on seven projects that will be implemented in three years. The VP and President Xi also agreed on the formation of strategic working plan that will follow-up the implementation of those projects under the second phase of Forum on China Africa Cooperation (FOCAC).

In total, the entire projects are estimated to cost over 10 billion US dollars. The projects are the construction of the central line to standard gauge, the Bagamoyo Special Economic Zone and revitalisation of Tazara. The railway and special zone projects are estimated to consume 80 per cent of the total costs. Central line will cost about 7.0 billion US dollars while the special zone project will take 1.0 billion US dollars.

Other projects that fell under the 2nd stage of FOCAC are infrastructure construction, power transmission lines, water, road and gas distribution pipelines in Dar es Salaam, Coast and Mtwara regions. They also include the extension of Sheikh Karume International Airport terminal buildings and Mpingaduni Port and deep sea fishing projects, all located in Zanzibar. Another area is e-education where a major centre will be constructed at Dakawa, Morogoro to facilitate recording programmes for secondary school subjects. The e-subjects will later be broadcast via internet to various schools and where there is no power, solar equipments will be installed.
