We are indeed moving ahead with a firm sense of resilience and responsibility, overcoming the unprecedented challenges brought about by COVID-19.

My association with the Chamber dates long back, however, since the onset of the pandemic in late March 2020, this association kept growing stronger. Past president Mr. Pradeep Bhargava and I (then Vice-President) realised that the city of Pune required a platform to enable collaborative action in responding to the catastrophic challenge of fighting the virus. Through coordinated action, the multistakeholder group, aptly named, Pune Platform for COVID-19 Response (PPCR), exemplified metaleadership abilities to cope up with the crisis.

The PPCR brought together people from all walks of life. This included healthcare professionals, business leaders, government officers, elected representatives, NGOs, amongst others. The platform, which was anchored at MCCIA delivered on-ground support through the pandemic.

It is encouraging and commendable to witness the commitment and faith amongst every member of the platform and it has been an honour as well as fulfilling experience for me to have had the opportunity to lead this nationwide drive. From raising funds to channelizing resources; from distribution of ration kits to arranging ventilators/HFNO's and from training medical staff to counselling citizens, PPCR has proactively pursued the cause of supplementing government efforts and help the system sustain the pressure.

The COVID-19 crisis had significant ramifications for the economy, livelihoods, businesses, and has



transformed business models. I am indeed proud of how MCCIA rose to the challenge and has extended their knowledge, experience, and initiatives to assist the industry to overcome the challenges endured upon. I would like to convey my gratitude to the unending cooperation from my colleagues on the Board, Executive Committee, and the active involvement of committee chairs, that enabled us to sail through these tough times and we concluded with a productive Financial Year.

Under the able guidance and leadership of the Director-General, MCCIA has made more representations to the Government, conducted more committee meetings, and organised more programmes as compared to last financial year.

The year also saw the continuation of some of the recently launched initiatives like the 'Digital Drive' to deliver more to our members by leveraging digital technology. We also launched some new initiatives like the 'Economic Research Unit (ERU)' to analyse and present public policies and trends relevant to the industry, commerce and agriculture. On the suggestion of our Board, we also launched a series on 'Family Managed Businesses' that demonstrated encouraging response from both faculty and participants.

As the pandemic upended the lives, unfurling fear and uncertainty, our role as a Chamber became even more critical to coordinate between the industry and the Government. We organised many sessions for interaction between the two. We are thankful to the then Minister for MSME, Shri Nitin Gadkari, and the Industry Ministry, Government of Maharashtra, for engaging with our members at the peak of the pandemic and responding to their questions and concerns. We also organised interactions for our members with senior Civil servants in the Mantralaya.

However, our most critical contribution lay in regular conversations with the local administration. On one hand, we continued to share feedback from the industry with the senior civil servants at the local level. On the other hand, we continued to communicate the extant Government Orders and Circulars to the broader industry members. Thousands of industry participants attended the interactions sessions organised by MCCIA with these senior Government officers Given the gravity of the situation, we kept such interaction sessions open for everyone, irrespective of their membership status.

Unfortunately, given the unusual situation, the year ended with some financial deficits for reasons beyond our control. I don't foresee the following Financial Year to be far better on this count either. However, I am glad to note that the Chamber, its leadership, and staff have put their best not just to continue but increase the magnitude and range of services provided and have risen to the occasion by setting up PPCR and serving the wider community.

From my discussions with the Board, Executive Committee, Director General, and his team, I am confident that during the next financial year as well, we will continue to deliver a significant impact on all possible dimensions.

I look forward to interacting with you at various MCCIA programmes throughout the year.

Let me end by wishing you and your loved ones a safe, healthy and happy year ahead.

DIRECTOR GENERAL'S MESSAGE

The impact of the pandemic over the last financial year has been felt by one and all. MCCIA was no exception to that. Given the business downturn and extant rules related to social distancing, many of our revenue sources took a severe hit. This impact translated into one of the rare instances of financial deficits for the year.

However, the overall impact of our member-centric activities increased during the FY. The environment of fear and uncertainty required the Chamber to be even more active in its role of facilitation, representation, and education. Over the last financial year, we made more representations, had more committee meetings, and organised more events for our members than the previous year.

With 250 Events and 5742 Unique organisations participating, it has been a meaningful year. We continued to build on some of the initiatives started over the past couple of years. We also launched new ones like the Economic Research Unit, The Family Managed Business Series, and the Digital Drive. This FY, MCCIA established the Economic Research Unit. The Unit primarily conducts Policy Research along with the analysis of Key Economic Indicators and Macroeconomic Data. In April 2020, the Chamber commenced the monthly HFEI (High-Frequency Economic Indicators) Publication, a compilation of key economic indicators that map and hint at the direction of the movement of India's and Maharashtra's economy.

Parallelly, the Chamber also started conducting the monthly Business Resumption Survey, which analyses the business and economic recovery of the industry in the Pune region. The Levels of Production stood at 26% during the initial lockdown in April 2020, and they improved to a healthier 83% in March 2021. Measuring the level of economic activity in employee deployment, the survey showed a marked increase from 21% in April 2020 to 86% in March 2021.

In addition to the HFEI publications, surveys and industry-related public policy research, the ERU shall



continue to build on to emerge as a centre of excellence focused on public policy analysis and recommendations in the domain of the industry in general and MSMEs in specific.

The Family Managed Business series launched on the advice of the Board of Directors has received an excellent response with 50 Family managed business owner-prompters, including some marquee companies / brands of Pune participated in the very first series. The positive response has encouraged us to continue this series soon.

In the defence sector, we have launched Defence Indigenisation Assistance Programme & have also Published Manufacturers Directory for Pune Region.

Our Digital Drive continues to progress with a) Social Media handles of the Chamber, b) Leveraging platforms of cloud that help us build better productivity to serve members better and c) Build our platforms to increase our reach and depth with industry in general and members in specific.

This year, MCCIA also initiated steps towards establishing a Common Effluent Treatment Plant in the Pimpri-Chinchwad area. We will endeavour to progress it to its completion by the end of the following Financial Year.

During FY 21-22, we shall continue strengthening the ongoing initiatives and increasing representations and learning and development programmes to deliver the much-needed impact. It would be prudent to note that given the second wave of the pandemic in the early part of FY 21-22, the outlook for the FY in terms of financials is not great. We would register another year of unusual deficit given the unprecedented pandemic. However, as mentioned above, we are very confident of delivering a significant impact on our

members and the broader industry through various services.

Beyond our responsibility towards our members and industry at large, the pandemic required us to also serve the broader community in dealing with the unprecedented situation. Thanks to the leadership of Mr Pradeep Bhargava and Mr Sudhir Mehta MCCIA launched PPCR (Pune Platform For Covid Response). Mr Mehta took the responsibility to be the lead convenor of this platform, and many stakeholders, including members and colleagues at MCCIA, joined the forum. The collective proved that collaboration and coordinated action could transform the seemingly impossible into the possible.

Before I end this message, Let me thank President Mr Pradeep Bhargava (till 25th September 2020) and President Mr Sudhir Mehta (there after) for their guidance. I am thankful to the Board of Directors, members of the Executive Committee and chairpersons of various committees for their help and advice. Of course, all the work delivered at Chamber is thanks to my hardworking colleagues at our various offices. My heartfelt gratitude to each of my colleagues who contributed towards this report, especially Ms. Anuja Deshpande for her lead in content compilation and editing. Last but not least, we must thank our members, our raison d'etre, for their very understanding approach in this challenging year.

MCCIA's 86th Annual General Meeting

The AGM was organized virtually and all the guests, Board of Directors, Executive Committee members, and members of MCCIA attended it online. The outgoing President of MCCIA, Mr. Pradeep Bhargava addressed the participants and welcomed the special guests, Mr. KV Kamath and Mr. Naushad Forbes. He spoke about the key milestones and achievements of MCCIA over the past two years. He also addressed industry associations saying that they have a responsibility to support the law and be a bridge between the industry and the government and concluded by bidding farewell to the MCCIA, saying that he is leaving its future in capable hands. He then passed the baton over to the new President of the MCCIA, Mr. Sudhir Mehta.

The President, Mr. Sudhir Mehta then addressed the meeting. He thanked Mr. Pradeep Bhargava for his words and expressed how honoured he was to be able to take up this responsibility. He spoke about the importance of industry leaders working together in this challenging period and how the goal going forward would be rebuilding for the longer term.

Mr. Mehta then set the agenda for the Chamber for the next two years. This included helping the Chamber's members, increasing organizational capacity in terms of human resources, enhancing network opportunities for the Chamber's member companies, strengthening institutions supported by the Chamber like the auto cluster and MECF, finding ways to enable new or modified enterprises and support small and midsized member companies. Mr. Mehta specifically highlighted PPCR as an example of stakeholders coming together to the aid of society in challenging times and being a part of the solution. He concluded by saying, "Businesses can be the force for change, national wealth creation and positive development and the chamber can be a magnet that brings together all stakeholders."

After this, Mr. Prashant Girbane, Director General of MCCIA introduced one of the special guests, Mr. KV Kamath, Former President, New Development Bank of BRICS Countries. Mr. Kamath addressed the meeting, speaking about the effects of the lockdown on the economy. He mentioned that the economy has recovered to a greater extent than he had expected. He reassured the participants that growth at higher rates for a long period will continue for India. He believes that the glass is more than half-full and expects growth to start by the end of the year, with second quarter numbers indicating where we stand more clearly.

He was of the opinion that going forward, India would rely on the banking sector to provide funding, for which the banks are prepared as a result of their strengthening through capital over the past years. He suggested that a hand holding plan will bring the economy back to normal, with improvements already visible in the second quarter numbers.

The second special guest, Mr. Naushad Forbes, Co-Chairman, Forbes Marshall Ltd. was then introduced by Director General, Mr. Prashant Girbane. He mentioned that the strength of the Indian economy rests on private individuals and private enterprises. He shared his belief that the diversity of opinion in the Indian industry is a strength, as opposed to the outlook in China.

He suggested that industry could have a dramatic

effect on national growth by making growth more inclusive. This can be done by focusing on education. He spoke specifically about primary education. His second task for the industry was equalising workforce participation.

He spoke about opportunities for industries to contribute to the national agenda and gave examples of such enterprises. He praised the way that Pune industry avoided load-shedding by implementing a cess under the leadership of Mr. Pradeep Bhargava. He spoke about the new labour laws being the first major step forward in balancing the need for flexibility, which was a result of the advocacy of industry members. He mentioned the need for self-discipline and the following of social distancing, mask wearing and hand washing protocols for our own safety and coordinating with the authorities to reduce infection rates in Pune. The program was concluded by Mr. Prashant Girbane with a vote of thanks.

Pune Platform for COVID-19 Response (PPCR) Dealing with the Pandemic, the PPCR way!

To assist the Government in dealing with the Pandemic, MCCIA set up Pune Platform for COVID Response (PPCR). Bridging the gap between demand and supply in the healthcare segment was the first task. Through the PPCR, the Chamber brought together doctors, healthcare workers, volunteer groups, equipping hospitals with the necessary infrastructure at the same time. The distribution of resources in terms of medicines, PPE kits, oxygen cylinders, ventilators, etc. was the next crucial step. MCCIA is grateful for the philanthropy of individuals and organisations that helped us do it. We managed to supply over 3,11,750 masks, 49,375 PPE kits, 51,350 face shields, 43,310 disinfectants, 3000 plus oximeters, and 6,00,000 Hydroxychloroquine (HCQ) tab-lets, among other essential COVID-related supplies.

Along with all this, the Chamber also took efforts in educating the medical fraternity and volunteers vis-a-vis effective care of the patients and management & use of equipment. Elearning came to the rescue. MCCIA facilitated this e-training free of cost.

With the number of positive cases growing, PPCR faced a new challenge: educating the citizens about the symptoms of COVID-19, relieving their anxiety and also making arrangements for testing for the virus. Accordingly, over 1,02,450 people were tested for the virus.

With the increasing number of COVID-19 patients, the need for hospital beds grew too. Management of hospital beds became a complex affair to tackle. MCCIA created a dashboard that gave real time information about the availability of beds in various hospitals in the district to patients and the local administration.

But soon the available hospital beds became insufficient. It was then that, with the support of

PPCR, the first 350 bed COVID Care Centre was set up in Pune. Today Pune's bed capacity has increased multifold and soon it will be at par with metro cities like Delhi, Mumbai and Chennai.

With industries having to shut down, the labour that depended on them were left stranded with no income and therefore, no means to survive in the city. Many tried to go back to their hometowns, but that too wasn't easy. PPCR, anchored at MCCIA, along with some NGOs mobilized resources to provide immediate relief to over 14 lakh people. Around 17,835 ration kits, 1,54,046 food packets, and 12,45,837 meals to the stranded, urban poor, and daily wage workers were distributed.

With the vaccine coming into the market, 2021 brought with it the promise of COVID-free times

> ahead. But accelerated and widespread vaccination was needed so that maximum citizens could benefit from it. MCCIA started coordinating with government authorities to make the vaccine available to as many as possible. One of the ways to do that was creating awareness of the benefits of vaccination and at the same time alleviating the fear and

misunderstanding among the common man about the side effects of the vaccine. MCCIA launched a vaccination awareness drive, wherein doctors and past presidents of the Chamber shared that the vaccine was safe and had minimal side-effects. They also appealed to the people to go ahead and get vaccinated.

As the financial year 2020-21 was coming to an end, we were hit by the second wave of the pandemic. This led to an enormous demand for oxygen cylinders, ventilators and hospital beds. In addition, other equipment like BiPaPs and oxygen concentrators. PPCR once again brought together the industry, NGOs and philanthropic organisations and got this mammoth task done.











Ministerial Visits To MCCIA



An online interactive session with Shri, Nitin Gadkari, Hon'ble Minister for Road, Transport and Highways; Micro, Small and Medium Enterprises, Government of India was organized on 31st May 2020. Shri. Gadkari addressed the members of the micro, small and medium enterprises (MSMEs) and spoke about the issues, relating to the COVID-19 pandemic. While touching upon the schemes and offers from the ministry, he encouraged the audience to keep doing their best during the trying times.


The minister told a gathering of over 400 entrepreneurs that Rs. 3 lakh crore has been sanctioned as collateral-free loans to MSMEs. MCCIA President Mr. Pradeep Bhargava urged the minister to help reduce the credit cycle to 30 days from 45 days for at least six months. The MCCIA survey found that the average amount owed by big companies to an MSME is Rs 2-3 crore. Shri. Gadkari said his ministry was considering the same. "The MSMEs can complain on Samadhaan, a portal, against big companies for delayed payments," he said.

On labour shortage, Shri. Gadkari said, "It is not true that the industry is dependent on migrant labourers. They constitute only 20% of the labourers on average for the industry. When the labourers return, industries also have to make sure that they take care of the workers."





Ministerial Visits To MCCIA



An online interactive session was organized with Shri Subhash Desai, Hon'ble Minister for Industries, Government of Maharashtra on 11th May 2020. Special invitees for this session were Mr. B. Venugopal Reddy, IAS, Principal Secretary, Industries Department and Dr. P Anbalagan, IAS, Chief Executive Officer, MIDC, Government of Maharashtra. The session was attended by 494 industry representatives. The discussions revolved around the challenges faced by the industry due to the pandemic, the government's take on it and the way forward to cope with the current situation. Mr. Pradeep Bhargawa, President MCCIA and Mr.

Prashant Girbane, Director General, MCCIA interacted with the dignitaries.

Interacting with industry representatives, Mr. Desai said, "As many as 25,000 companies in Maharashtra have resumed operations. Around six lakh people working in these 25,000 firms have got back to work. In western Maharashtra alone, 9,147 industries have been permitted to restart work. Of these, a total of 5,774 have already resumed operations".

- **b.** 24th June, 2020: the Emergency Credit Line Guarantee Scheme announced by the Finance Ministry to help the MSMEs. A request was made to allow cooperative banks to extend the benefits. Similar representation was also sent to Shri Nitin Gadkari Hon'ble MSME Minister, Government of India

Dilip Walse-Patil,** Hon'ble Labour Minister, Government of Maharashtra on 16th April, 2020, for providing relief to the industries, especially the MSMEs and another representation was sent on 22nd June, 2020, with suggestions on introducing Fixed Term Employment.


Ahmednagar


and Education were discussed.





She stressed the need to prioritize one's time and to give in one's 100% to the task at hand. While talking about her learnings from running a business, she mentioned that the business needs to be flexible to adapt to any adversities. Business needs to have contingency plans in case of unforeseen incidents. According to her, to be successful in a business, it is important to study the needs of the society, map competencies within the organisation and be consistent with one's value systems. Her mantra of "Karun tar baghu" shows her risk taking ability and the constant curiosity to try something new. Ms. Madhuri also mentioned the importance of one's responsibility towards the society they live in and shared anecdotes from her social initiatives.






MCCIA Survey on Resumption on Economic Activity in Pune Region FY 2020 - 2021

This Financial Year, MCCIA established the Economic Research Unit. The Unit primarily conducts Policy Research along with the analysis of Key Economic Indicators and Macroeconomic Data. In April 2020, the Chamber commenced the monthly HFEI (High-Frequency Economic Indicators) Publication, a compilation of key economic indicators that map and hint at the direction of the movement of India's and Maharashtra's economy.

Parallelly, the Chamber also started conducting the monthly Business Resumption Survey, which analyses the business and economic recovery of the industry in the Pune region. The Levels of Production stood at 26% during the initial lockdown in April 2020, and they improved to a healthier 83% in March 2021. Measuring the level of economic activity in employee deployment, the survey showed a marked increase from 21% in April 2020 to 86% in March 2021.

In addition to the HFEI publications, surveys and industry-related public policy research, the ERU shall continue to build on to emerge as a centre of excellence focused on public policy analysis and recommendations in the domain of the industry in general and MSMEs in specific







MCCIA Electronic Cluster Foundation (MECF), promoted by MCCIA and supported with 'Grant In Aid' by MeitY, Govt. of India and 'Financial Assistance' from Government of Maharashtra, is setting up a Brownfield ESDM Common Facility Center (CFC) in Bhosari. By which, MECF will boost the electronic ecosystem of Pune and surrounding areas by helping the electronics industries in terms of latest technology, cost competitiveness and shorter turnaround times, thus enabling the Pune region to become a default destination for electronics design led manufacturing. In short, MECF will be a step towards support in creation of world-class infrastructure in electronics system and design manufacturing.

MECF has received the two tranches of 'Grant in Aid' from Central Government and Financial Assistance from State Government of Maharashtra. The civil work of about 34% has been completed till March 2020. A Public Tender had been published for the procurement of equipments for EMI / EMC and Test and Certification Verticals. The tender received very good response from the industry and the evaluation of the bids and selection of the vendor process was initiated.

- Skill Development centre for Employees of MSMEs and Engineering Students


