Our dedicated efforts to equip entrepreneurs with robust Capability-Building Programmes post-COVID-19 have yielded significant results, enhancing the resilience and competitiveness of our business community. These programmes have been vital in up skilling and preparing our workforce for emerging market demands.

Collaboration with government officials has been a cornerstone of our advocacy efforts this year. We have engaged extensively to address critical industry issues and advocate for policies that foster sustainable economic development. This collaborative approach has facilitated smoother business operations and paved the way for impactful policy reforms benefiting our members.

Central to our functioning over the last two years has been our intensified support of MSMEs. This highlights our commitment to nurturing a robust business ecosystem in Pune and beyond. Our initiatives have also focused on empowering women entrepreneurs through dedicated support and capacity-building programmes under the Centre of Excellence for Women Entrepreneurs (CEWE). This platform has become a pivotal hub for fostering entrepreneurial aspirations among women, providing them with the necessary tools and resources to succeed in today's competitive business landscape.

Another focal point of our advocacy efforts has been addressing the persistent challenge of delayed payments for MSMEs. I am pleased to note that our sustained dialogue with policymakers has borne some fruits, resulting in concrete steps such as incorporating Section 43B (h) in the Income Tax Act, which aims to ease cash flow constraints for our member enterprises.

Our strategic initiatives in collaboration with the defence sector have gained significant traction, mainly through establishing the Aatmanirbhar Centre of Excellence Pune (ACOEP). This initiative stands as a testament to our commitment to fostering innovation and technological advancement in collaboration with academia and industry partners, thereby enhancing the capabilities of MSMEs and Start-Ups from this region.



Furthermore, MCCIA has recently facilitated visits to Germany to discuss future mobility, Dubai to explore opportunities for exports of agricultural produce, and the UK to gain insights into battery technologies in electric vehicles.

These international engagements have provided invaluable global exposure to the delegates, equipping them with insights and opportunities to enhance their competitiveness in a rapidly evolving market environment.

The fifth Pune International Business Summit 2024 was a significant milestone. The summit convened diplomats, senior government officials, industry leaders, and participants from Pune and abroad, highlighting Pune's growing prominence on the global economic stage. We organised over 100 B2B meetings with delegates from abroad to benefit participants at the Summit.

Sessions featuring industry stalwarts and international speakers emphasised India's potential to lead in the various market sectors through technological advancements and a shift towards clean energy solutions. This forward-looking approach underscores our commitment to fostering innovation and sustainable growth across industries.

I am happy to report that the Maharashtra State Electricity Distribution Company Ltd. has recently issued a circular enabling small electricity consumers and MSMEs with a contract demand or sanctioned load of 100 KW or more to avail of Green Energy Open access. We have been pursuing this important proposal with the Maharashtra Electricity Regulatory Commission and the Government of Maharashtra in line with the notification from the Central Government.

We started the first HR Shared Services cluster to provide comprehensive HR Solutions exclusively tailored for MSMEs, enabling them to leverage economies of scale and pool expertise.

As my tenure as President draws to a close, I am immensely proud of our progress together. I am quite conscious that many initiatives started over the last few years would require persistent efforts to reach their logical end.

I extend my heartfelt gratitude to the dedicated team at MCCIA, our esteemed members, committee chairpersons, executive committee members, and board members for their invaluable contributions and steadfast support throughout this journey.

I am confident that MCCIA will attain greater heights and contribute even more significantly to the economic development of the Pune region and Maharashtra State in the future.

DIRECTOR GENERAL'S MESSAGE

By the beginning of the financial year, COVID-19 was a thing of the past. While there were still some companies that had not achieved their pre-COVID levels of business volume and profitability, those were far fewer than the majority of businesses that had transitioned from the 'recovery' to the 'growth' phase.

Throughout the year, the Chamber was occupied with broadly three sets of activities. The first set of initiatives included activities that we have been doing for decades, like the membership development and subject matter committee meetings. The second initiatives set included activities that we started in past five years, like the Agri Exports Facilitation Centre (AEFC) and Family Business Forum. The third set included activities that we started in FY 23-24, like the Centre of Excellence for Women Entrepreneurs (CEWE) and the Technical Skill Elevate programme for employees of our member companies.

Let me cover some activities from these three sets. In terms of membership growth, the Chamber added 750 new members, the majority of whom were MSMEs. The existing members and new members together formed various subject matter committees. Throughout the financial year, more than 50 committee meetings were organised. The committee meetings helped in setting the agenda in terms of advocacy and capability building programmes. To advance the advocacy agenda, we interacted with 101 individuals, including ministers and senior officials (IAS, IFS, IPS), as well as officers at local government levels. To take forward the capability building agenda, the Chamber organised 111 programmes to help companies build capabilities in their human resources. The programmes were attended by 5309 individuals from hundreds of companies.

While subject matter committees formed by members help us understand the challenges faced by members, we are supplementing it by regular visits to factory floors of our members. My colleagues and I visited 104 factories over the year to better understand on-ground challenges. Some of the companies requested the Chamber to organise international delegations to further their business and hence we organised five international delegations.

Businesses learn a lot from each other and hence to facilitate that sharing and learning we created a platform on the YouTube (https://tinyurl.com/4f58rzr9) where we interviewed one entrepreneur every week and captured her/his journey from startup to sizeable manufacturing MSME. We have received encouraging feedback online and in person on these 52 interviews uploaded in FY 23-24.

In this two-year term of FY 22-24, thanks to advice from the President, we focused on building a state-of-the-art CEWE (Centre of Excellence for



Women Entrepreneurs) focused on providing a co-working space for budding women entrepreneurs and offering twenty different services under one roof.

Over 150 women entrepreneurs benefited from the one-on-one consulting, and a total of 939 women entrepreneurs attended the programmes organised by CEWE.

Over the past nine decades the Chamber has grown from strength to strength with almost all of our activities concentrated in the Pune district. Over the past 12-18 months, in terms of outreach, we have reached to ten more districts where we conducted capability-building programmes to help MSMEs in those districts. This is certainly first such attempt in history of the Chamber and given encouragement by the board and the executive committee we would further build on this impact in terms of depth (more activities) and breadth (more districts).

Above mentioned activities in the sphere of 1. Skill enhancement, 2. Women Entrepreneurship and 3. Outreach beyond Pune district addresses the broad goals set by the President in last FY (22-23) and highlighted in Director's Report of FY 22-23

Throughout the year, we continued to strengthen the governance at the Auto Cluster, which the MCCIA established with the funding support from the Government of India and the Government of Maharashtra. The Auto Cluster continues to help hundreds of large and small companies use expensive machinery on a pay-as-you-go basis, thereby reducing time to market and increasing profitability for companies in the Pune region and wider Maharashtra.

The MCCIA Electronic Cluster Foundation, also funded by the Government of India and the Government of Maharashtra, is being established with the aim to provide EMI, EMC, test, measurement, and design services to hundreds of companies in the electronic manufacturing sector. Similar to the auto cluster, the electronic cluster will also help companies in the Pune region reduce time to market and increase profitability.

The Chamber will continue its efforts to deliver more services to even more members and set up clusters that help the broader economy in the region and the state.

In the upcoming year (FY 24-25), the Chamber will continue to build on all three broad sets of activities, with a particular emphasis on helping MSMEs in the Pune district and beyond. We aim to help 10,000 MSMEs through FY 24-25, more than ten times what we have ever done in one year. We would also leverage the RAMP (Raising and Accelerating MSME Performance) initiative of the Government of India and the World Bank with the support of MSSIDC to achieve this goal of assisting 10,000 MSMEs in Maharashtra state.

Let me take this opportunity to express my sincere thanks to my colleagues at the Chamber for all the activities and achievements of the year. I am grateful to our members, various committee chairpersons and its members, executive committee members, board members, and the council of the past presidents for their timely inputs and guidance. My special thanks to Mr. Deepak Karandikar, the President, for his involvement, guidance, and encouragement throughout the year.



CIVIL AVIATION

Another was sent on 23rd June 2023 appealing for the existing plot to be reserved for a Common Facility Centre, and an alternative for the CETP was sought.

Hon'ble Dr. Bhagwat Karad, Minister of State, Government of India, was sent a representation on 21st August 2023. His intervention was requested in the proposed amendment to Section 43B of the Income Tax Act, explicitly addressing the disallowance of payments to MSMEs after 45 days.

A representation requesting rectification orders for Local Body Tax in PCMC limits was sent to **Dr. K.N. Govinda Raj,** Secretary, Urban Development II, Government of Maharashtra, on 21st November 2023.

Hon'ble Shri. Piyush Goyal, Minister of Commerce and Industry, Government of India, was handed over a representation on 24th November 2023 concerning the issue of delayed payments to MSMEs.

A representation was sent to **Dr. P.K. Mishra**, Principal Secretary to PM, Prime Minister's Office, Government of India, on 18th December 2023, requesting his intervention to address the delay in payments to MSMEs.

On 29th January 2024, a representation was sent to **Dr. Vipin Sharma (IAS)**, Chief Executive Officer, MIDC, seeking clarification about the Development Control Rules notified in July 2023 and the steep hike in Development Charge notified in January 2024.

ENERGY

On 20th April 2023, **Hon'ble Shri. Chandrakantdada Patil,** Minister for Higher and Technical Education, Government of Maharashtra, was sent a representation requesting his intervention in encouraging Green Energy Open Access to MSMEs in Maharashtra.

Shri. Sanjay Kumar (IAS Retd.), Chairman-Maharashtra Electricity Regulatory Commission, was sent a representation about Green Energy Open Access for MSMEs on 8th May 2023, followed by another on 4th August 2023, requesting his intervention to form a committee tasked with drafting regulations for this initiative.

Shri. Mahesh Landge, Member of the Legislative Assembly for Bhosari Constituency, was sent a representation on 14th October 2023 on addressing issues related to facilitating the establishment of a Group Captive Solar Park for Small Electricity Consumers.

Jitendra Bhole**, Secretary In-charge of the Maharashtra Legislature in the Government of Maharashtra, on matters concerning the Mathadi, Hamal, and Other Manual Workers (Regulation of Employment and Welfare) Act, 1969, and the Maharashtra Private Security Guards (Regulation of Employment and Welfare) Act, 1981.

Pol** also appealed to HR officials to check the contractors' documents and the salaries given to contract labourers.

Numerous issues concerning the industry at large were discussed during this interaction with other government officials from various departments present.









An industry interaction focusing on the indigenisation opportunities available to industries was held on 7th December 2023, with Dr. Samir V. Kamat, Secretary, Department of Defence R&D, Government of India, and Chairman, Defence Research and Development Organisation (DRDO). Dr Kamat highlighted various areas of interest for Defence and elaborated on the possibilities for collaboration with the industry. The interaction was chaired by Mr. Deepak Karandikar and attended by over 70 industry representatives.

ADDRESS BY DR. MOHAN BHAGWAT

18TH SEPTEMBER 2023

Special address on **Philosophy of India's Economic Policies** -by Dr. Mohan Bhagwat, Sarsanghchalak,
Rashtriya Swayamsevak Sangh

Dr. Mohan Bhagwat, emphasised India's economic outlook of viewing business as serving others rather than personal ownership. Dr. Bhagwat delved into lessons from ancient India's decentralised economy, stressing limited consumption and societal betterment. He highlighted the humane basis of Indian business, promoting productivity through automation but not impacting employment and renewable energy use. In closing, Dr. Bhagwat shared his views on the utilisation of wealth, referencing past norms, and predicted a bright future for India.



IMPORTANT MEETING TO DISCUSS MATHADI RELATED ISSUES

An Important Meeting to discuss issues relating to the Maharashtra Mathadi, Hamal, and Other Manual Workers Welfare Act, 1969, was held on 12th July 2023 at Autocluster, Chinchwad. Various topics like the applicability of the Mathadi Act, registration of industrial and Commercial Undertakings as well as Mathadi Workers, and practices observed from Registered / Unregistered Mathadi Unions were discussed. Senior Officials from the Police Commissionerates of Pune and Pimpri Chinchwad, Pune Rural Police, the Department of Labour, the Mathadi Board, Labour Law Experts and Mathadi Labour Unions addressed the participants.

The key takeaways were the need for standardisation of wages payable to Mathadi workers in the Pune District, Withdrawal of Criminal Cases against HR Managers about the implementation of the Mathadi Act, Anti Extortion Cells of the Pune and Pimpri Chinchwad Police would take strict action against those who solicit money without any work in return and the Labour Department would need to add manpower to ensure the smooth implementation of the Mathadi Act, for the benefit of the industry and workers.

A session was organised on 1st August 2023 dealing with drones/anti-drone technologies on the MCCIA Zoom platform, with representatives from the Israel Consulate & SIBAT. Companies working in this domain got a chance to present their capabilities to Israeli officials. This session aimed to gauge expectations and possibilities for collaboration with Israeli companies for joint research, product integration, and distribution partnership.

A meeting with Godrej Aerospace (GA) Officials was organised on 24th August 2023 to discuss opportunities for MCCIA members to supply to GA. Members of MCCIA's Defence Committee and Senior Godrej Aerospace Officials were present during this discussion.

The committee conducted a seminar on **HR as a tool for wealth maximisation** on 3rd May 2023. The session focused on facets such as analysing company financials, cost-benefit analysis, income tax calculations, and assessing return on investment.

A seminar on **Financial Management - Advanced Level** was conducted on 07th June 2023. Skills like computation of cash flow, usage of Advanced Capital Budgeting Techniques, and reducing costs through inventory management were imparted to the participants.

A working group for the semi-conductor eco-system under the MCCIA Electronics Committee was formed on 1st September 2023 with the help of domain experts from MCCIA & MECF. This group aims to cover the following areas:

- Technology (Including Designs & Manufacturing)
- Operations/Project Management (Including Supply Chain)
- Finance (Including Guidance/assistance for Funding)
- Branding and Marketing
- Governance and Auditing

The Semicon group had arranged a lecture series to attract participation in this initiative. Attendees from diverse verticals and professions, such as MSMEs, scientists, students, professors, researchers, and other employees, were invited to these sessions to gauge avenues for their participation. Seven lectures were organised, and the response was encouraging.

The first lecture was held on 21st October 2023 on **Verticals of Semiconductor Industry.** The session was conducted by Prof. H. S. Jattana, Former Scientist G, SCL-ISRO and focused on the nitty-gritty of the semiconductor industry, its transformation, and various technical specifics. The speaker expounded on Fabrication and Fab support operations, different CMOS foundry utilities and local fabrication, post-fab operations required, and opportunities, concerns, and challenges in the Indian scenario.

On 28th October 2023, Lecture 2 was held on the topic of **Business Opportunities in the Semiconductor Domain and New Skilling Requirements.** Conducted by Dr. A. D. Shaligram, Professor Emeritus of Electronic Science and CEO of SPPU Research Park Foundation, the session focused on various aspects of the semiconductor industry in India, its history, and the evolution of Microelectronics technology. The distinguished speaker also elaborated on other technical specifics, such as the VLSI Design Cycle, Material Chip Mounting, and Fab Labs.

Lecture 3 in the series was conducted on 04th November 2023 by Dr. Uday Sheorey. The session was on the topic of **MEMEs in Indian Semiconductor Mission, DOs, DON'Ts, and Opportunities** and focused on important factors when looking for business opportunities in the Semiconductor domain.

Mr. Apoorva Kapse conducted Lecture 4 on 18th November 2023, titled **IP Design Cycle & its Significance to SoC Development.** It focused on areas like the basics of IP, IP in the context of the semiconductor industry, IPs based on industry standards, different categories of IPs, IP development skills, business functions, and success stories.

Conducted by Mr. Prasen Vinchurkar on 16th December 2023, the theme for Lecture 5 was **Silicon for Indian Semiconductor Ecosystem.** The interaction revolved around the Market and global key players of Si wafers, Silicon in India and the Global Si Wafer market.



On 23rd December 2023, Lecture 6 was held on **IC Fabrication** with Dr. Vanita Agarwal as the key resource person. The important pointers during this discussion were Technology Scaling and its challenges, the International Roadmap for Devices and Systems, Cleanroom processes, Advanced CMOS future trends and the Importance of Compound Semiconductors.

Mr. Bhairav Shah conducted Lecture 7 on 30th December 2023 with **Packaging** as the subject. Various valuable insights were shared during the session on the Importance of Packaging in the Semiconductor industry, Case Studies on SMD LED Packaging plant, Assembly, Testing, Advanced Packaging and recent trends. Mr. Shah also delved into Market specifics and talked about Key Market players.

The session detailed the annual mandates of statutory and specific compliances, an overview of legal and procedural amendments, and an analysis of key amendments and their impact on trade and industry.

The Committee organised a session on 12th May 2023 with **Input Tax Credit and Reverse Charge Mechanism - Emerging Challenges and Likely Solutions** as the theme. ITC and RCM basics, details of issues, and Judgments against and in favour of taxpayers were discussed at length during this workshop.

The committee held a session on **Various Beneficial Schemes under Customs and Foreign Trade Policy for Importers & Exporters** on 30th May 2023. During the session, the critical benefits of minimising CAD through export trade, the philosophy of 'Atmanirbhar Bharat' and 'LOCAL goes GLOBAL' as well as Hightechwere covered.

A Seminar was held on 12th July 2023 to discuss **Common Errors, Issues, and Disputes faced under GST.** The session also covered a Checklist of various procedural systems to reduce the risk of errors.

Effective and error-free filing of GST returns was taught during a session on 4th October 2023, which covered topics like Common errors and resolution in filing returns, familiarisation with updated GST policies and its impact on Monthly returns.

The Chamber organised two Agri Export Market visits to Dubai, with the first one between 23rd and 28th July 2023, and the second from 18th to 23rd February 2024. The participants comprehensively explored Dubai's agricultural trade during both visits with a meticulously planned itinerary. The highlights of the visits included visits to the Cattle Feed market, meetings with key traders and distributors, and tours of Al Aweer Market, Fruits Market, and Vegetable Market. Furthermore, the visitors engaged in a Trade Facilitation Briefing, followed by a dynamic Buyer-Seller Meet. The tours balanced business insights with cultural experiences and offered a well-rounded understanding of Dubai's agriculture landscape. The second delegation took the participants to the Gulfood Expo, providing them with exposure to global food trends. A total of 44 Agri-Entrepreneurs and exporters participated in these delegations.









SYMPOSIUM ON THE ONION AND GARLIC ECOSYSTEM

The National Symposium Cum Industry Meet (NSIM) -2023 was held on 20th & 21st December 2023. The Agri-Business Incubation Centre (ICAR) Directorate of Onion & Garlic Research, MCCIA & Indian Society of Alliums were the organisers.



The event laid holistic focus on the Onion and Garlic Ecosystem and covered facets like their exports, logistics, scientific research, agricultural practices, vital processing and sales.

A highlight of the event was the presence of eminent speakers from the Onion and Garlic industries, who conducted sessions on various areas of the trade and participated in Open Forum Discussions. Furthermore, another focal point was the Launch of Products by ABI incubatees and ICAR Representatives. Keynote Lectures were conducted during the event by scientists from research institutes and universities, who gave insights into the scientific details of how to improve Onion and Garlic production. Lastly, the event also included an Exhibition of commercialised agriculture technologies.

AGRITECH STARTUPS

In a notable collaboration, MCCIA partnered with renowned cricketer Ajinkya Rahane to bolster the agricultural sector through groundbreaking initiatives. The motive behind this partnership is to support start-ups and small-scale companies, particularly in the Agri-tech domain, fostering growth and sustainability.

Under the banner of 'Ajinkya Rahane and Associates', a significant fund of Rs 1 crore was initiated, marking a proactive step towards holistic empowerment. MCCIA established a committee comprising experts from various fields to analyse and evaluate the potential of startups in the Agri-tech sector. This committee diligently assessed factors such as innovation, scalability, market potential, and social impact. Rahane and his associates closely collaborated with this committee to make informed investment decisions that aligned with their shared mission of catalysing positive change in farming practices.

The investment in Krushak Mitra Agro Services Pvt Ltd served as a prime example of the initiative's dedication to driving meaningful transformation in agricultural practices and uplifting rural communities. Currently, the committee is actively evaluating other promising Agri-tech companies, expanding the potential for impactful agricultural innovation and sustainability investments.



MCCIA CYBER SECURITY INITIATIVE

MCCIA and the US Consulate General in Mumbai felt the need to enhance the IT sector and drive digital transformation in Pune. With this objective in mind, a Cyber Security Initiative has been set in motion by the MCCIA'S IT/ITES Committee and the Commercial Services of the US Consulate General.

This partnership's core emphasis is establishing Technology-specific Centres of Excellence (CoEs) in Cyber Security, AI, IoT, and Quantum Computing. A Cyber Security programme will be launched initially, followed by potential expansion into other CoEs.

The Cyber Security initiative has been envisaged with three main objectives: creating a platform for US and Indian companies in the sector to do business in Pune, fostering skill development in Cyber Security across various stakeholders and facilitating business connections between US and Indian companies. This setup would be driven by leveraging MCCIA's extensive network and experience. Future collaborations with other countries possessing relevant expertise are also in the pipeline. Interactions would be catalysed through the Cyber Security programme, and existing resources would be utilised through funding from stakeholders leveraging the launch pad for business growth. A reasonable membership fee would be levied to ensure sustainability, and establishing a working group would detail the initiative's charter based on its objectives and long-term vision. Several US companies have been invited to participate in this initiative. Specific challenges and opportunities within Cyber Security will be identified to attract the right players to maximise output and ensure success.

Significant progress over the last few months has laid solid groundwork for a conducive cybersecurity ecosystem owed to support from the US and Israel Consul Generals. Partnerships are being concretised with knowledge partners like IIT Bombay Trust lab, COEP, VJTI, and DIAT; incubators like Bhau Institute, and professional bodies like ACM and IEEE. These relations would synergise diverse stakeholder skills and contribute to seamless operations.

This session saw a special focus on the growing challenge of cyber threats and the rampant spread of misinformation in the age of social media. Dr. Altshuler emphasised the ease with which misinformation could now be generated and disseminated by virtually anyone equipped with simple tools, leading to widespread propaganda and narrative manipulation.

INDUSTRIAL RELATIONS CONCLAVE 2023

7TH DECEMBER 2023



















The Mahratta Chamber of Commerce Industries and Agriculture (MCCIA), Pune, organised a day-long IR Conclave 2023 on Thursday, 7th December 2023. The event focused on Proactive Industrial Relations, the HR/IR fraternity's role in preventing conflicts at the workplace, aligning the non-permanent workforce with the company's business needs, and inducing proactiveness among attendees to face challenges better.

The inaugural session was graced by Mr. Pradeep Bhargava, Past President, MCCIA, Mr. Deepak Karandikar, President MCCIA, Mr. Prashant Girbane, Director General, MCCIA and Adv. Shriniwas Inamati, Director, Deccan Management consultants and Chairman of MCCIA's HR & IR Committee.

Various sessions were conducted as follows:

SESSION 1: IR CHALLENGES IN DIVERSITY AND INCLUSION

The Panel discussion on this interesting topic saw eminent panellists like Mr. Glynn Jones, Country Manager and CEO, Gestamp Automotive India and Ms. Kavita Kulkarni, Global CHRO, Varroc. The discussions were steered by Ms. Arnabi Marjit, Vice President - HR, R&D and Biotech, Lupin Ltd. Ms. Kavita Kulkarni noted the low representation of women in manufacturing but highlighted efforts by companies like Tata Motors, Ola, and BASF to address this issue. Mr. Glynn Jones advocated employing the 34% untapped women workforce, citing their productivity and value as assets. Finally, Ms. Arnabi Marjit emphasised the need for HR to dispel the misconception that higher costs would be incurred with hiring more women, promising long-term benefits from their competence and skill.

SESSION 2: IMPACT OF TECHNOLOGICAL CHANGES ON IR

The highlight of this session was an exciting discussion on the impact of technology-induced changes in the last few years and its impact on the industry. The panel also discussed how we can leverage this impact for positive changes.

The panel coordinator, Ms. Priyanka Shakyawanshi, Regional HR Director – India, Gestamp Automotive India, introduced the panellists, and the topic and ably steered the discussions. The panel members sharing their views were Mr. Sharad Gangal, HR Consultant, Chairman, TJSB Sahakari Bank, Dr. Sadashib Padhee, Executive Director, C4i4 Lab under the aegis of Ministry of Heavy Industry (MHI) and Ms. Nazneen Hussain, HR Director -Engineering, Information Technology, Global Analytics, Integrated Supply Chain, Cummins Inc.

Mr. Gangal stressed the challenge of finding skilled HR officials, suggesting it may urgently surpass technology challenges. He advocated for large-scale training, which is crucial for meeting the global demand for skilled labour and would be particularly beneficial for India. Ms. Nazneen discussed Cummins' workforce strategy amid COVID-19, focusing on adapting to the new normal, automation, and addressing skill gaps. In the end, Dr. Sadashib Padhee outlined Heavy Industries' strategy, emphasising the need for a mindset shift to adopt technology effectively, especially on the shop floor.



SESSION 3: INFLUENCE OF JUDICIAL PRONOUNCEMENTS ON IR

Adv. Shriniwas Inamati, Director of Deccan Management Consultants and Chairman of the HR & IR Committee of MCCIA steered the discussions of this session.

Adv. Ashok Gupte, Senior Labour Advocate, spoke about the various changes in the legal landscape since the 1980s, especially in the area of retrenchment and dismissal of employees. He also gave instances from a recent court judgement that underline that though laws are the same, their interpretations need to change to remain current with the changing times.

Mr. Ajit Abhyankar, CITU Pune, spoke about the judicial thinking behind deploying contract labour in the manufacturing industry. He cited that contract labour has no right to claim permanency and cannot be absorbed as per the law. He mentioned that the judiciary lays complete onus of the proof of contract to the contractual labour and not the principal employer/contractor. An exciting round of Q&A followed the discussion.

SESSION 4: PROACTIVE AND INNOVATIVE IR APPROACH WITH CASE STUDY

The Panel Coordinator, Mr. Kuldip Joshi, an Independent Consultant, spoke about innovation as an ongoing process that should soon become the norm and must be strived for in the IR sector.

Adv. Vivek Vibhute, representing DMC Legal, underscored the intricate nature of Industry Relations, framing it as a behavioural science. He illustrated this concept with the transformation witnessed at Kirloskar Oil Engines, where adopting HR best practices led to a transition from aggressive to assertive leadership. Dr. Santosh Bhave, Director of HR & IR at Bharat Forge, emphasised the proactive mindset crucial for IR professionals. He elaborated on the significance of learning from past errors, effectively managing situations, and utilising data for strategic planning, pointing to Bharat Forge's approach as a prime example. Lastly, Mr. Kuldip Joshi highlighted the valuable insights small companies, helmed by innovative entrepreneurs, can offer to understand the essence of innovation.

The conclave received a considerable response. It was attended by 125 Participants from the HR IR Fraternity. Christ University, Lavasa, Pune, was the Gold Sponsor for this mega event.
