PRESIDENT'S MESSAGE



Dear Members.

For more than eight decades, The Maratha Chamber of Commerce Industries and Agriculture (MCCIA) has risen to facilitate industrial growth while balancing the socio-economic environment. At the heart of our commitment to the public good is our mission. It grounds all of our activities and aspirations.

This past year, just as we were recovering from the wrath of the first wave of the pandemic and the economy was on its way back to normalcy, we were struck with the second wave in April 2021. I remember when the second wave kicked in, Pune too was struggling for oxygen availability like all other hotspot regions. In February - March 2021, numbers started increasing, symptoms were changing, and the younger population was getting affected.

As the impact of the second wave worsened across the country, Pune Platform for COVID-19 Response, an initiative by MCCIA, launched 'Mission Vayu', one of the largest civic-led initiatives to support the healthcare infrastructure and tackle the then pertaining oxygen shortage. Under Mission Vayu, within just eight days of identifying the shortages, PPCR managed to establish connections with the medical equipment suppliers across the globe, arrange logistics, raise the funds, coordinate with the Governments, and distributed medical equipment to various healthcare institutions in and around Pune and across the country.

As a result of this, there was a 735% increase in COVID-19 bed capacity, and a 451% increase in the ventilators capacity by May 2021, enabling Pune with the highest COVID-19 beds and ventilator capacity in the country. The success of Mission Vayu is to be largely attributed to the MCCIA team, along with the PPCR members. From obtaining necessary approvals to ensuring that the equipment is delivered and deployed in record time, the MCCIA team's resilience and collaborative effort ensured seamless execution.

I am extremely proud of their hard work and

grateful to our Board and the Executive Committee for their cooperation and support in ensuring Mission Vayu was a success. Though we faced unprecedented situations due to the pandemic, we were able to end the year on a productive note. Thanks to the able leadership of the Director General and the efforts of his team, MCCIA continued to serve the industry at large.

As the pandemic brought in uncertainty and disrupted businesses, MCCIA's role of coordinating between the Government and the industry became even more important. MCCIA continued to stay connected with the relevant Government officials to ensure there was smooth communication to the industry regarding the easing of restrictions and opening up of businesses. We organized many interactive sessions with local Government officials so that the queries and concerns of the industry members could be answered. We are grateful to the Government officers and senior civil servants who readily accepted our invitations and actively participated in these interactive sessions.

Apart from the special covid-related activities, MCCIA also focused on its usual functioning to support the industry in the region as you will find detailed in this report.

This year, we also pursued the civil aviation requirements of Pune including increasing the domestic and international air connectivity of the airport, upgrading the facilities at the airport, increasing the size of the cargo hold area and the cargo terminal, extension of the runway, and need for an independent international airport in Pune district. We made extensive correspondence with the Prime Minister's Office, Minister for Civil Aviation, Chief Minister of Maharashtra State, officials from the Ministry of Civil Aviation, Ministry of Defence, and the Airports Authority of India. We also held regular interactions with decision-makers from various Indian airlines.

MCCIA continued to take other important industry issues and recommendations to various Government leaders and officials. We are thankful to the Government leaders who spared their valuable time to interact with our Members at the Chamber. Shri Prithviraj Chavan, Former Chief Minister, Maharashtra State, Hon'ble Shri Subhash Desai, Minister for Industries, Maharashtra State, and Dr. Bhagwat Karad, Minister of State for Finance, Government of India graced us with their presence during various meetings to discuss issues faced by the industries. We also continued interactions with ambassadors and consul generals from various countries to discuss bilateral opportunities for trade and investment, especially at the Pune International Business Summit 2022 where we hosted diplomats from more than 12 countries.

The Chamber understands that sustainability of businesses and cities is crucial for the economic development of a region. While MCCIA continues to run its Sustainability Desk which helps many companies become more cost-efficient while reducing their carbon footprint, MCCIA is also working with the local administration to set up a Common Effluent Treatment Plant in PCMC. This is currently a work in progress and shall be ready to serve the PCMC area in a couple of years.

Serving as the President of the Chamber for the last two and a half years has been an extremely gratifying experience and I go into the last six months of my tenure with a strong sense of optimism. The 80-year-old unblemished legacy of MCCIA nurtured by my predecessors is invaluable and it has been my pleasure to be at the helm of affairs of one of the country's most respected and reputed organizations.

I would like to conclude by thanking the board and members of the council of past Presidents members for their unending support at the Chamber. I look forward to meeting and interacting with all of you in the coming year.

DIRECTOR GENERAL'SMESSAGE



Dear Members,

I am pleased to present to you the Annual Report for the FY 2021-22.

The impact of the second wave of the Covid pandemic on Pune city had significant implications. It was time to step in and face the challenge through collaboration. PPCR, anchored at MCCIA provided a platform to ensure synchronisation of efforts and worked as a citizen front to provide the necessary help. PPCR launched Mission Vayu in April 2021, and through this initiative, raised resources to procure and to distribute over 1000 ventilators, and 8000 oxygen concentrators across the state of Maharashtra and some other parts of the country. This activity ensured that each and every Government hospital in the state had at least some ventilator/BiPAP and oxygen concentrator capacity and demonstrated how we can come together and channelise efforts to achieve a common goal.

Despite the unforeseen circumstances put forth by the pandemic, MCCIA managed to make some surplus that is essential for organisational sustenance. This was a relief after a year of deficit last financial year. Though we are not yet at the surplus levels of the pre-pandemic year, I am confident that with the continued efforts of my colleagues at the Chamber, we would get there by the next financial year.

During this financial year, we continued our efforts to serve the industry at large. We organised 126 capability-building programs which benefitted 8,839 participants from 2,623 companies across the region. We also continued to build upon some of the initiatives we had launched previously as well as launched some new ones.

As a part of MCCIA's Economic Research Unit, we continued the monthly survey to study the resumption

of economic activity in the Pune region. The data shows that the average production levels rose from 69% in April 2021 to 98% in March 2022. The average employee strength rose from 70% in April 2021 to 95% in March 2022. This positively indicates that Pune's economy is recovering well. We also continued to publish the monthly High-Frequency Economic Indicators (HFEI) which are a compilation of key economic indicators that map and show the direction of the movement of India's and Maharashtra's economies.

The Family Managed Business series launched on the advice of the Board of Directors has received an excellent response last financial year and so we continued our efforts in that direction this financial year as well, by launching the second and third series. Once again, we got a good response with another 40 family business owners participating in this series. During the next financial year as well, we shall continue to build on this.

We also continued to build upon other recently launched initiatives like the Agriculture Export Facilitation Centre (AEFC) with NABARD (National Bank for Agriculture and Rural Development). AEFC has helped and continues to help hundreds of farmers by raising awareness about the potential for their exports. The centre also provided guidance to 266 farmers during the last financial year to explore specific geographies and products for exports.

MCCIA continued its efforts towards the Digital Drive. As a part of this drive, MCCIA launched the Urban Data Observatory which has geo-tagged data across Pune city for improved urban governance. MCCIA also launched the digital certificate of origin for export which helps exporters save on time and travel costs and has already served 120 companies as on 31st March 2022.

MCCIA has always had a special focus on MSMEs and in this regard, the Chamber launched the MSME Scheme Facilitation Centre to provide guidance to MSMEs trying to avail the benefit of the various Government schemes. Over 300 MSMEs availed benefits of this Centre during the last financial year.

The Chamber continued to take the grievances and feedback of the industry to the relevant Government officials. During the last financial year, MCCIA made 30 representations on behalf of the industry on areas including changes to the labour codes, GST and MSME act frameworks.

In a bid to support women entrepreneurs, MCCIA had organised an exhibition exclusively for women entrepreneurs to showcase their products and services. The second edition of the Women Entrepreneurs directory was also launched during the exhibition. In the defence sector, MCCIA had organised a defence expo where the latest edition of the Defence Directory was launched.

The Chamber is known for creating the institutional capability to support members in various industry domains. Institutions like AutoCluster and NAFARI (National Agricultural and Food Analysis and Research Institute) are examples of these institution-building efforts in the past. These institutions continue to help hundreds of companies, especially MSMEs in the auto and food processing sectors. Over the past few years, the chamber has invested significant efforts to set up MCCIA's Electronic Cluster Foundation (MECF) with the help of the Government of India, the Government of Maharashtra and industry partners. Thanks to the work done over the last FY and this FY, MECF is now ready to be launched in early FY 2022-23.

As we step into the new financial year, I have renewed confidence that the Chamber would continue to serve its members even better and continue to rise to the ever-changing demands of the industry. All of this is thanks to the efforts put in by my colleagues at the Chamber and members and chairpersons of the various committees, guidance from the Council of Past Presidents, and with support from the Executive Committee, the Board, and the dynamic president, Dr Sudhir Mehta.

MCCIA's 87th Annual General Meeting

he 87th Annual General Meeting (AGM) was organized virtually on 23rd September, 2021 and all the guests, Board of Directors, Executive Committee members, and members of MCCIA attended it online. President of MCCIA, Dr Sudhir Mehta welcomed all the attendees to the meeting. Since the quorum for the meeting was met, he declared the meeting as commenced. Dr Mehta started the meeting by introducing ordinary resolutions. In all, nine resolutions were passed unanimously. These included the appointment of Mr Deepak Karandikar, Ms Rujuta Jagtap, Air Marshal Bhushan Gokhale, and Mr Milind Kamble as Directors and the appointment of Mr Gautam Bambawale as the ambassador of the chamber.

After the formal part of the meeting was over, the floor was opened for everyone to ask questions. Attendees could ask questions by posting them on the chat box. It was suggested that in view of the pandemic, due consideration can be given to the members of MCCIA in terms of paying the membership. Mr Prashant Girbane, the Director General of MCCIA mentioned that such a provision has already been put in place. Dr Mehta thanked the Past Presidents, and the board members for all the support throughout this difficult year of pandemic. He specially thanked and expressed a deep sense of gratitude to the team of the chamber who, except for a few days worked from the office throughout the pandemic and went above and beyond the call of duty. Dr Anand Deshpande thanked the current president, Dr Sudhir Mehta, the past president, Mr Pradeep Bhargava, and Director General, Mr Prashant Girbane for leading the chamber in such difficult times. Thereafter Mr Prashant Girbane declared the AGM part of the meeting to be concluded.

Dr Mehta introduced the chief guest of the day, Mr Manish Singh, IAS, District collector of Indore, Madhya Pradesh, who spoke at length about the transformation of the city of Indore. He gave the credit for Indore's transformation as a city when it comes to cleanliness and waste collection and segregation to its strong leadership. In 2015, the city of Indore was facing dire challenges concerning disposing of garbage. Some things that he mentioned that were identified and needed to be addressed were to keep the staff motivated, give appropriate mobility options for the staff, availability of machinery for waste collection, and whether there is a need for an external agency to collect the





garbage. After investing heavily in developing a fleet for garbage collection, a state-of-the-art workshop was developed. The fleet of vehicles caters to 8 different categories-road sweeping, litter bins, meat collection, bulk waste, door-to-door collection, construction and debris, garden waste, and sewer waste collection was developed. Mr Singh emphasized the role of involving NGOs in the collection activities and educating people on wet and dry waste segregation. Mr Singh felt that it is very important to keep the waste segregated right from source to collection to processing, segregation is the most important function of a waste management system. He also appreciated the role of the media in covering all the good initiatives undertaken by the corporation.

Mr Singh appreciated the Government of India's SBM toolkit; he felt it is a very scientifically prepared toolkit. Installing litter bins throughout the city of Indore proved to be helpful in keeping the city clean. The beat system used in policing was implemented for the deployment of personnel. The city had moved towards performance-based monitoring from attendance-based monitoring. A vehicle tracking and monitoring system proved to be very effective in terms of adopting a data-centric approach. The processing of wet waste happens at three locations at the central plant, organic waste converters installed at restaurants and large organic waste converters installed near city gardens. Lots of initiatives have been taken which have motivated people to adopt an approach to recycling and reuse. This has led to the development of initiatives like recycling gardens, plastic premier league, zero waste premises, etc. The IPL was a zero-waste event as well. The grievance redressal mechanism is very strong in Indore. Indore was also able to achieve the status of water plus city, with all discharge treated before it is released into the rivers. Mr Prashant Girbane appreciated the efforts taken by the city and its collector and concluded the program with a Vote of Thanks.

Because of this, it was requested on 9th April, 2021 that such vendors and shops be allowed to operate by following the COVID-19 protocol. Mr Saurabh Rao, Hon'ble Divisional Commissioner Pune, accepted the request.

Agriculture Export Facilitation Centre

- Mahratta Chamber of Commerce, Industries and Agriculture, MCCIA, in association
 with the National Bank of Agriculture and Rural Development, NABARD, launched
 the Agriculture Export Facilitation Centre, AEFC, on 15th May, 2021, via a digital
 platform.
- Dr G R Chintala, Chairperson, NABARD, inaugurated the Centre in a virtual program. Mr Umesh Chandra Sarangi, IAS Retd, Chairperson, Agriculture and Agricultural Business Committee, MCCIA, Mr Dheeraj Kumar, IAS, Agriculture Commissioner, Maharashtra, Dr Sudhir Mehta, President, MCCIA, and Mr Prashant Girbane, Director General, MCCIA, were also present at the inauguration program. Mr Ajinkya Rahane, Member, Indian Cricket Team, also marked his presence through the virtual platform.
- MCCIA, in association with the NABARD, started the Agriculture Export Facilitation Centre, which was physically inaugurated on 1st July, 2021, at the hands of Mr G S Rawat, CGM – Pune RO, Mr Umesh Chandra Sarangi, IAS Retd, and Mr Prashant Girbane, Director General, MCCIA,. The physical centre is set up for all the aspirants who desired to start venturing into the agriculture export business.
- The MCCIA-AEFC, in association with the Agriculture Technology Management Agency, ATMA, a wing of the Department of Agriculture, Maharashtra signed an MoU to train 1000 farmers on agriculture export.







MCCIA's Safety Sale Activity for National Safety Week 2022

Safety activity was carried out successfully in 2022, like every year. For the last 31 years, the MCCIA has been providing safety awareness materials, such as badges, posters, slogans, banners, flags, poster books, calendars, etc. to industrial units in and around Pune to use during National Safety Week. This year, the National Safety Week was observed across the country between 4th to 11th March, 2022. The materials were provided to various industries in Pune, Pimpri Chinchwad, Chakan, Pirangut, Ranjangaon, Shirur, Bhor, Ahmednagar, Kolhapur, Satara, Sangli, etc. worth more than Rs 15 lakhs.

The main aim was to create an awareness of safety among the industrial employees and ultimately to reduce the accidents to zero level. The material was made available through the MCCIA's Tilak Road and Hadapsar branches in Pune, Bhosari branch in the Pimpri Chinchwad and Ahmednagar branch for the convenience of the industries. Around 500 industrial units and 100 construction companies responded.

Waste Disposal Mechanism for Industries in the Pimpri Chinchwad Area

The Pimpri Chinchwad Municipal Corporation, PCMC, has undertaken the 'Swacchagrah' mission to make the area clean, hygienic, and livable. The MIDC area, which comes under the PCMC administration, is also a part of this mission. MCCIA is supporting this initiative. Under the leadership of Hon'ble PCMC Commissioner Mr Rajesh Patil and other PCMC officials, several rounds of meetings were held to identify and finalize the disposal mechanism for various waste materials generated by the industrial units. Five different areas were identified viz. Industrial effluent, industrial sewage, hazardous waste, non-hazardous domestic waste, and non-hazardous industrial waste. The committee prepared and presented the disposal mechanism flowchart to the Hon'ble Commissioner. The committee also organized meetings of the local industry associations.

MCCIA has requested the PCMC to create a collection centre for industrial hazardous waste in the PCMC area. The PCMC is planning to establish a material recovery facility at Bhosari MIDC to collect and dispose of industrial non-hazardous waste. PCMC is also planning to lay drainage lines for the collection and disposal of industrial sewage. MCCIA is supporting the "PCMC CETP Foundation", an SPV formed to establish and operate the common effluent treatment plant. All these measures would help make PCMC's industrial area clean, hygienic, and pollution-free. These waste disposal mechanisms would, directly or indirectly, benefit over 6000 industrial units in the PCMC area.

Common Effluent Treat Plant (CETP) in PCMC area

As per MPCB data, about 400 Industrial units in PCMC-MIDC area generate hazardous effluents. The number could go up if the industrial units operating without MPCB consent are considered. Since there is no arrangement for collecting and treating the effluent, many Industrial units find ways to discharge these effluents, leading to soil and river pollution. MCCIA, with the support from MIDC, PCMC and MPCB,has initiated concrete steps for establishing a permanent solution in the form of CETP. An SPV viz. PCMC, CETP foundation has been created for the purpose. MIDC has reserved a plot inthe Bhosari Industrial area for the CETP. The necessary application and documentation process has been initiated to obtain possession of the said plot



from MIDC, to the SPV. Several rounds of discussions were held with the different stakeholders viz. PCMC, MIDC, MPCB, Local Industrial Association, and the members of the SPV. The scope for the DPR has also been finalized in consultation with the PCMC and DPR work is expected to be completed by 30th September 2022. The CETP would directly provide benefits to about 500 Industrial units. MCCIA coordinates with all stakeholders in the execution process and provides active handholding support.

Scheme Facilitation Cell

The MSME Ministry and other ministries have several schemes for the MSME sector. However, the information about the schemes is not percolated down to the MSMEs and thus, the MSMEs cannot take advantage of the schemes. The MSME committee created a "Scheme Facilitation Cell", SFC, to bridge the gap between the Government and the member MSMEs. The objective of the SFC was to provide information and handholding support on various Government schemes. The cell activities include awareness creation, resolving queries, assistance in the application process, coordination with the stakeholders and policy advocacy.

The SFC prepared a scheme document in FAQ format comprising 47 schemes. The SFC spread information of nine schemes and also organized awareness sessions on five schemes viz. PLI scheme for food processing industry, Mr S K Verma, Director, Ministry of Food Processing Industry, NSIC scheme, Mr Bikash Chandra Naik, Dy GM, SIDBI scheme, two sessions – Mr Rudra Prasadnna Mishra, AGM, SIDBI, Z scheme 9Mrs Sanjeevani Gogawale, ZED Experts,.

The SFC received responses and further queries from 113 members and efforts were made to resolve their questions and arrange meetings with concerned Government officials. About 325 members benefitted from the activities of the SFC.

Lean Cluster Initiative

In the last decade, the MSME committee supported 129 SMEs in strengthening their manufacturing and organizational capabilities through the Lean Manufacturing Cluster scheme of the Ministtry of MSME, Government of India. The committee successfully formed and executed 14 lean clusters. The activities of the 14th cluster were successfully completed in March, 2022. The fifth and last mile stone-based audit was conducted on 25th and 26th March, 2022.

The committee also extended support to four OEMs by forming seven clusters of their supplies. The OEMs were Kirloskar Oil Engines Ltd, 4 clusters, Cummins India Ltd, 2 clusters, Piaggio Vehicles Ltd, 1 cluster, and Godrej appliances, 1 cluster,. The other seven clusters comprised of SMEs from a cross-section of the industries.

The committee also provided support to 29 SMEs by forming and executing the cluster for Advanced Lean Implementation.

All clusters were formed under the National Productivity Council, a national monitoring and implementing unit appointed by the M/o MSME to execute the LMCS scheme at the national level. MSME Development Institute, Mumbai, performed an essential role as the monitoring agency.

The Experts' View Dr Mahendra Kalyankar

- Upon MCCIA's request and interventions, the Government extended the deadline for filing returns under various labour laws, and the administration could ensure that the workers are paid the overtime allowance as per the rules.
- 'Work from Anywhere' will replace the 'Work from Home' trend. A customized strategy with a focus on employee wellness and holistic development is the need for the hour.





Mr Rajeev Dubey

- A just, equitable, and inclusive IR framework is a necessity. Governments, businesses, and society must come together to recognize IR as a strategic success factor.
- The contract and informal labour issues are a ticking time bomb, and a collaborative approach is needed to address the challenge.

Mr Pradeep Bhargava

- Why did it take the pandemic for us to acknowledge that we need to change IR when all other verticals like technology, products, delivery, sales, etc were transforming rapidly?
- With the new Labour codes, employers will have accountability for all employees. Job permanency will become a myth and employee performance will be given weightage.

Adv Sanjay Singhvi

- If we compare the number of labour laws being followed in the United Kingdom and the United States of America, what was the need to consolidate the labour laws?
- The uncertainty of employment is necessary to provide a decent standard of living for all the employees and India needs more formalization in the workforce.

Late Adv R Y Joshi

- The intention behind the new Labour codes is to bring down the number of disputes, increase the inflow of capital, establish more industries, and boost employment.
- There is no clarity on what will happen to the Maharashtra Recognition of Trade Unions, MRTU Act and there is also ambiguity regarding the applicability of the standing orders and Chapter VB of the Industrial Disputes Act.

Dr Ranjan Mehrotra

- As the current situation stands, we are not in the post-COVID-19 era and the future seems uncertain.
- COVID-19 has created a shrinking pie for most enterprises and we will have to learn to save and help those that are affected the most.

Adv Shrinivas Inamati

- Various contingencies were faced by businesses before 2020 and various approaches were used to tackle them.
- COVID-19 led to complex problems, which had no best practices to derive solutions from.

Mr Sharad Gangal

- We must be concerned about people who are creating value on the shop floor and whether the organizations have considered the wellbeing of those in contingency plans.
- It would be gracious on the part of stakeholders to plan for contingencies rather than them being forced.

Prof J Phillip

- The new labour codes would bring better order to the chaotic IR situation in India. In the new codes, the Government is no longer a partisan, but an active catalyst in the process of growth and development.
- The COVID-19 pandemic has given all the concerned parties an opportunity to reflect on the post-pandemic era, which will be distinguished by mutual communication and partnership.

Mr Sitaram Kandi

The sessions were organized for six consecutive Fridays, starting from 16th July, 2021.

Day I – 16th July, 2021

The inaugural speakers for the day were Mr Vivek Chand Sehgal and Mr Laksh Vaaman Sehgal.

Mr Vivek Chaand Sehgal, Co-founder and Chairperson, Samvardhana Motherson Group, in his inaugural address, shared the journey of Motherson from 1975 till today. Mr Laksh Vaaman Sehgal, Vice Chairperson, Samvardhana International Limited, shared his experience of transitioning into the business and gave insights into the performance review system at Motherson.

• Day II - 23rd July, 2021

Our first speaker for the session, Mr P. M. Kumar, Advisor, Human Endeavour, spoke about the complexity of succession planning. According to him, succession is not linear, but a 360-degree process involving multiple stakeholders.

The second session on the second day was 'Secrets of Rapid Growth- The CavinKare Way' and was hosted by Mr Koushik Shekhar, Investor and Entrepreneur,.

Ms Nidhi Jain, Director, Pride Purple Group, joined her husband's business when the business was growing at a fast pace, but needed a system that would sustain this growth. Working in a family business means the entire organization becomes a part of your extended family and you create bonds that are beyond the corporate realm."

• Day IV - 6th August, 2021

Mr Raman Nanda's session revolved around an interesting question- 'Does a family business founder have to be a superman or a superwoman?' He spoke about the different roles a family business founder has to play, namely the business CEO, family head and owner of the business. He believes that to be a "superman" or a "superwoman", one needs to succeed in all three roles. Mr Nanda reminded the audience that even "superman" or "superwoman" should ask for help when in need.



Mr Narendra Kale, Member, Board of Directors, Kale Logistics Solutions, spoke about his journey by sharing the lessons he learned from different stages of his life. Mr Kale's closing remarks were about the inspiration behind establishing Bhau Institute, the startup incubator at the College of Engineering, Pune, and his mantra on becoming a successful entrepreneur.

Dr Ganesh Natarajan, Executive Chairperson, 5F World, shared he believed in the 3Ps – profit, people and planet, also known as the triple bottom line since the inception of his organisation. Dr Natarajan cautioned the audience that even though it is important to dream big, it is equally important to ensure the building blocks are in place. To conclude, Dr Natarajan said, "If you want followers, you can easily get them. But if you want leaders, you have to let them lead."

Day V - 13th August, 2021

To conclude, Mr Berlia stated that effective governance supports growth, scale and results and it does not mean more bureaucracy, expense or regulations.

Mr Forbes' concluding remarks were, "(Family businesses, must remember three processes- communication, resolving issues within the family and do not keep secrets within the family."

Timeous Interventions by PPCR

The impact of COVID-19 outbreaks in Pune city and its surroundings had significant implications. Though the State and the Central Governments were preparing to tackle the situation at hand, everyone knew that our healthcare infrastructure would have to bear tremendous stress. During the first wave, everything was a surprise for us. No one knew how to control the spread and treat the patients. Governments were doing all they could, but it was not enough. It was time to step in and face the challenge of collaboration. PPCR – a platform to ensure synchronisation of efforts – worked as a citizen front to provide all the necessary help. This was a demonstration of how we can come together and channelize and efforts to achieve common goals.

The Second Wave and Mission Vayu

The shock wave of the unforeseen catastrophe was settling down in February 2021, and the economy was on its way back to normalcy. Just when everyone felt well, the second wave of the coronavirus infections hit Pune hard. This time, most of the patients needed medical oxygen supply. No city in the country had enough medical oxygen for patients to cater for the sharply rising demand, and the crisis deepened. Realising the need to step up the medical oxygen supply infrastructure, PPCR started various activities parallelly. Within just eight days of pinpointing the problem, PPCR managed to establish connections with the medical equipment suppliers across the globe, arrange logistics, raise the funds, coordinated with the Governments, and distributed medical equipment to various healthcare institutions in and around Pune and across the country.

Pune, unfortunately, has been affected by both waves. Before the second wave of infections, Pune's oxygen demand was 60 tonnes a day. During the peak of the second wave, it went up to 350 tonnes a day. No system can work if the demand goes up by 500 per cent. To combat this crisis, we realized we need to have a multipronged approach.

Collaboration has always played an integral role in development. In the global COVID-19 pandemic, collaboration must be seen as the key to progress, - a collaboration between governments, sectors, and the stakeholders in any situation.

The role of the Government must be that of an enabler, and the power of citizens and NGOs must be harnessed. Mission Vayu launched during the peak of the second wave is an apt example of this triumvirate, which is completed by coordination. All the coordinated efforts resulted in the successful implementation of one of the largest civic-led initiatives – Mission Vayu."

We are all used to working in silos. During the first and second waves of the coronavirus pandemic, concerns were coming through various mechanisms. However, the nature of the calamity was the binding thread that kept us together. It was not just the clinical thing that PPCR was facing; it was also about livelihood. During this period, MCCIA and PPCR did so much work in regard to government policies, opening offices, factories, etc.

After addressing the need for medical infrastructure, PPCR moved on to the next big thing – the vaccines. Our only defence against COVID-19 was vaccines. Hence, the PPCR changed its colours from healthcare to vaccination; from relief to prevention.

PPCR is a concept, a platform that can provide care – not just from the medical point of view. Here is an opportunity for all the stakeholders to come together on issues that relate to citizens. We can look at it as the 'Pune Platform for Care and Relief.'"

PCR, a virtual entity, is anchored and steered by MCCIA. The benefit that PPCR had and will continue to have is that the MCCIA itself has a long history of eight decades. So, all the systems and processes required for dealing with a multi-stakeholder group already existed.

All my colleagues in MCCIA worked day in, and day out. A few of my teammates were constantly connected to the hospitals – the demand side of the equipment. The funding and supply side was looked into by a few others. Another group of members was dealing with the logistics of securing the consignment at the airport, ensuring that all the paperwork was being done, etc. All the approvals from the Central and State governments came within minutes. The collaboration front was easier for MCCIA because it is an industry association. Hence, we could deal with everyone, right from the big donors to individuals who wanted to contribute a few hundred rupees.

We now know that if something happens, we can all come together and rise to the challenge."




